

Living Endowment conducted a survey this fall to discover what you thought of the plan and what your ideas were for improving our campaigns. The response was excellent and we want to thank those who answered. It was very clearly indicated to us that we needed to tell you more about Living Endowment and how it works.

First of all . . . Living Endowment has no desire to offend anyone. It is a simple plan worked out by a group of alumni, to enable you as an alumni to endow the college no matter what your income. Some of our alumni are in income brackets which would forbid a gift of \$200.00 but permit one of \$10.00. Some are in a bracket that would make a gift of \$10,000 impossible but permit one of \$500.00.


