The first basketball game to be televised from Allee Gymnasium was seen over KVTU on Saturday, January 12, when the Maroons defeated the Iowa Teachers 78 to 72. This was the third conference win for the Maroons. They defeated both North Dakota State and North Dakota University, but lost to South Dakota State.

This was the first game to be televised in the North Central Conference, and the first of any of the smaller colleges in this area, Coach Buckingham reported.

At half time the television audience was entertained by the Morningside Band accompanying the majorettes in a baton twirling drill. Then the cameras were trained on the Allee Gym pool to show synchronized swimming by college girls under the direction of Dr. Mary Bowne, director of physical education for women.

IN MEMORIAM

A. W. Jones of Cherokee, Iowa, banker and philanthropist, December 12, of cancer. Mr. Jones was born on a farm near LeMars in 1878. He attended Morningside College and later became a benefactor of the institution.

The A. W. Jones Science Hall on the campus and the Marian Jones Hall of Culture are witnesses of his generosity to the college. Survivors include the widow, a daughter, Mrs. Joe Nelson of Cherokee, a son, Robert of Chicago, a sister, Mrs. Landsberg of Sac City, nine grandchildren and three great-grandchildren.

Dale Norton, class of 1919, of Spencer, on November 19 in Des Moines from injuries received in an automobile accident on November 9 as he was driving to the Iowa — Minnesota game. Mr. Norton was an automobile dealer, president of the Spencer school board, and executive vice-president of the Iowa Automobile Dealers. He was an outstanding athlete in college and retained his interest in athletics and in his college. He was a valued member of the Board of Trustees and of the Alumni Living Endowment Committee. He leaves his widow and three children, Sandra, Sybil and Dale Jr.

Dr. W. A. Johnson '30, physician and surgeon, on October 3 after a heart attack at his home in Iowa Falls. After graduation from Morningside he took his medical training at the University of Iowa. Following military service he settled in Iowa Falls. The citizens of that community have contributed to a Memorial Fund for him which is to go for scholarships to needy medical students, to the Iowa Heart Fund, and for candelabra for the Methodist Church in Iowa Falls.

Dr. Frederick J. Plondke, who was graduated from Morningside College in 1895, died on January 5 in St. Paul. He was 87 years old. Dr. Plondke had practiced as a physician and surgeon for 62 years. He received his doctor of medicine degree from the University of Pennsylvania. He served on the staffs of several St. Paul hospitals, and in 1911 founded St. John's Hospital in that city. He served as chief of staff there until his retirement.

Dr. Plondke attended the 60th Anniversary Celebration at the college in 1954 and was presented an honorary degree at the 1955 Commencement.

Allen P. Berkstresser, class of 1910, died on December 17 in Sterling, Colorado after a short illness. Mrs. Berkstresser, Inez Whiney '13, passed away in June. Two daughters survive. Howard Berkstresser '11 of Honolulu and Dr. Charles Berkstresser (15) of Sioux City are brothers.

Fae Siman Mahood (04) on December 12 in Santa Barbara, California of a heart ailment. She was the wife of Dr. W. R. Mahood, formerly of Sioux City. Survivors include the widower, two daughters, Mrs. Vernal Brinks and Mrs. Stanley Matthews, a brother, Ray Siman and two sisters, Mrs. Harry Cain of Evanston and Hazel Siman Mahood of Sioux City.

Dr. Ernest C. Richards '99 of Salem, Oregon, on September 29 after a long illness. Dr. Richards was ordained a minister in 1906 in the Northwest Iowa Conference. He also was a teacher in Iowa for several years. Mr. Richards joined the faculty of Willamette University in 1916 and for 23 years taught and served as head of the English department.

He was graduated from Morningside College in 1899 and was given an honorary degree in 1939. Mrs. Richards was the former Myrta Milner, a member of the class of 1905 and lives at 1240 No. 21st St., Salem, Oregon.

Miss Alice McElrath, a former trustee of the college, died at her home in Moville on November 23.

Miss Estelle Roberts, a faculty member from 1908 to 1912, at her home in Seattle, May 6, at the age of 82.

Mildred Blanchard '46, English instructor in the Vermillion schools, died after several months of illness. She is survived by her mother, Mrs. E. Rodlund of Vermillion, two sisters and two brothers.

George B. Crouch (20) of Spencer, Iowa, on December 16 after a heart attack. He leaves a daughter, Mrs. Walter Flint of Yankton, South Dakota, a son William, a sister Lois, class of '13, Wayne, Nebraska, and a brother, Byrkit of Sioux City.

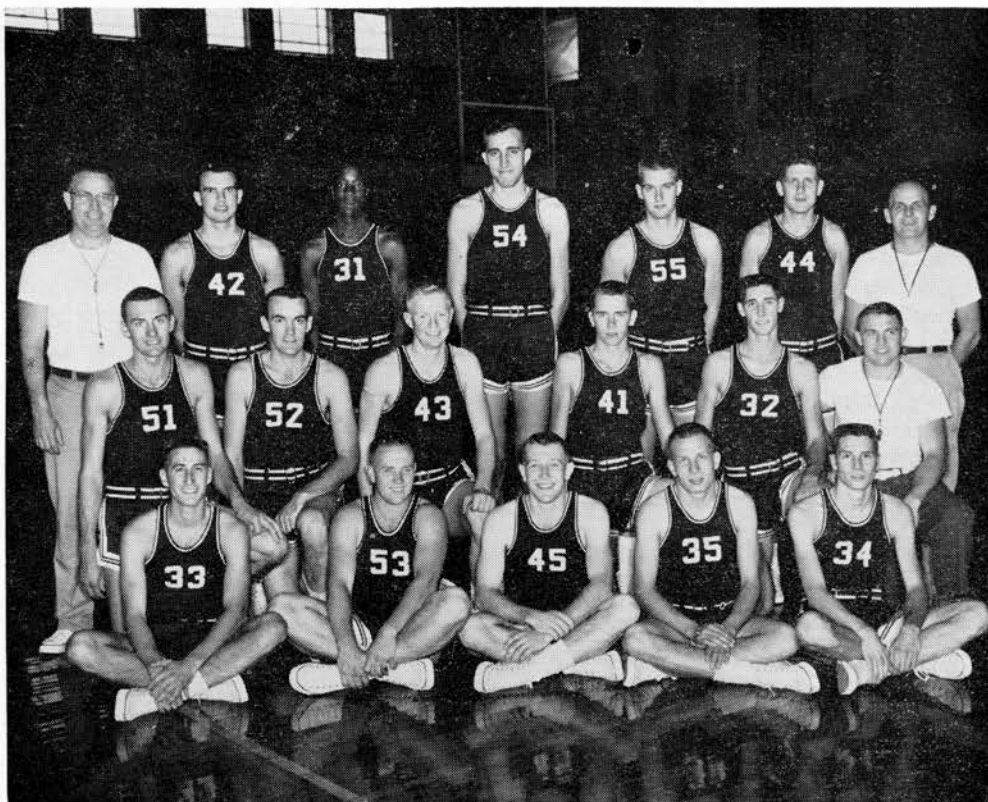
