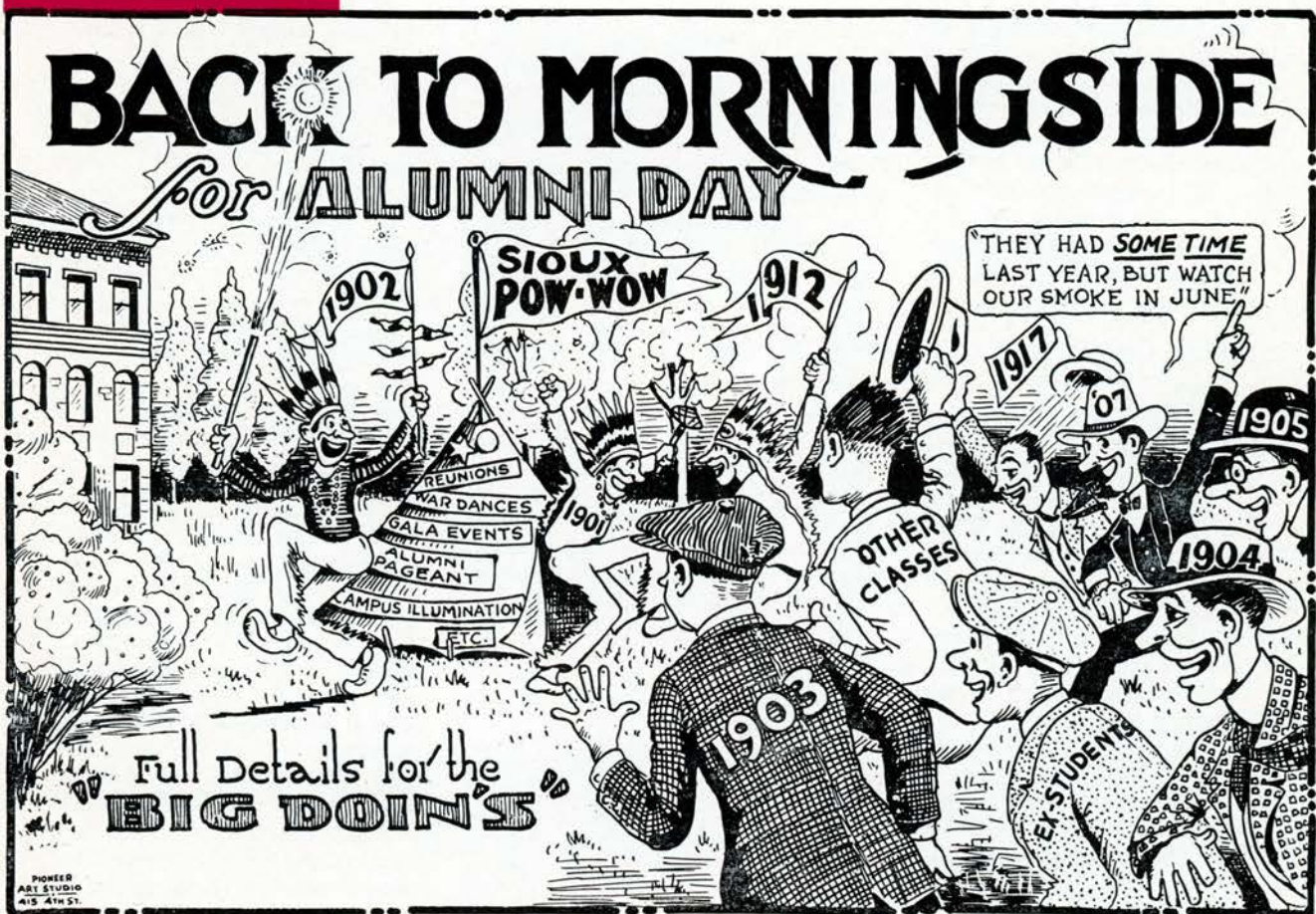

## Spring Sport Picture

Aspirants for positions on the baseball and track teams are working out indoors, hoping for spring weather that will permit them to go outdoors. ## \$160,000 Library Improvement Project

Morningside College has embarked upon a project to double the number of volumes in the college library within the next eight years.

The project calls for \$160,000 to be spent for new books and rebinding of older volumes in the period from 1963 to the school year 1969-70. This year, \$5,000 was allotted for new books. That figure will be matched again next year. This year's budget for replacement, binding, and new books is \$17,500. Then, beginning in 1964-65 and continuing for six years until 1970, \$25,000 is to be expended for new books each year.

According to librarian Virgil Wynne, the Morningside library has 56,000 volumes at the present time. Mr. Wynne says that the proposed expenditure will be sufficient to double the number of books now on hand.

The library regularly receives 360 periodicals. There are also 4,000 pamphlets available covering a wide variety of subjects. The library recently purchased a Kodagraph Microfilm Reader to facilitate reading periodicals and books in microfilm. It is also equipped with a Microcard Reader for books and periodicals available on microcards. There is an increasing number of rare books, and a valuable collection of autographs and prints.

## Tuition Increase for 1963-64 School Year

President J. Richard Palmer has announced a one-hundred dollar increase in total expenses at Morningside College for the 1963-64 school year. Included in the increase is a seventy-dollar tuition rise, twenty dollars for room, and ten dollars for board. President Palmer stated that the \$70.00 tuition increase would be used for faculty salaries.

In announcing the increase, the Board of Trustees of the college emphasized that Morningside College has not been increasing expenses excessively in comparison with other area schools.

A survey of the four Methodist colleges in Iowa (Cornell, Iowa Wesleyan, Simpson, and Morningside) shows that Morningside has had the smallest percentage of increase in the last seven years. Cornell has increased expenses 75% since 1955; Iowa Wesleyan's costs have risen 62%; at Simpson expenses have gone up 54%; and at Morningside costs have increased only 51% in the same period. Morningside College's total cost will still be below the others. A comparison of college costs in the surrounding area shows that Morningside ranks favorably.

In a survey of the other three Iowa Methodist colleges, the state schools in Iowa, one eastern institution, and others of interest in the Midwest, Morningside ranks 12th among the 23 schools in terms of percentage increase in the past seven years and is below the average increase for all schools.

Every institution except one made substantial increases during this period, even though some were relatively high in the first place. Morningside has hardly kept pace with the cost increases by the schools surveyed and has lost ground relative to all other Iowa Methodist colleges. In fact, of the 22 other schools included in the survey, 13 had higher costs than Morningside and only 9 were lower.

The seventy-dollar tuition increase will be used directly for professor's salaries. The total salary budget will continue its increase of recent years. Dr. J. Richard Palmer states that "This makes it possible for Morningside College to compete for well qualified instructors with other colleges and universities as well as

with government and industry. Also, the salary schedule has been revised, extending the upper limits in each category. A full professor may now receive up to \$12,000 a year."

The one-hundred dollar increase puts the total for tuition and general fees, room and board at \$1,530 for the academic year. Tuition, beginning in 1963, will be \$750 per year, or \$375 a semester; room costs will be \$240 for the year; and board charges, \$410. Student general fee is \$130 per year.

## Parents Day Held

Morningside college played host to parents, December 8, with the college's annual Parent's Day. Parents were invited to the campus to view the college facilities, visit with professors, and participate in varied activities.

The highlight of this year's Parent's Day was a banquet at 5:15 p. m. in the college Commons. Students and parents attended the banquet, and Dr. Allen K. Jackson, Morningside's Dean, addressed the group.

The day began with registration at 1:30 in the Commons. The parents were greeted by Dean Jackson and by the student body president, David Bones, of Wahoo, Nebraska. An informal session at 2:45 in the Petersmeyer Library enabled parents to meet and visit with faculty and administrative personnel.

From 4:00 to 4:45, parents had the opportunity to visit the men's and women's residence halls and the International House. The banquet was followed by the Morningside-Nebraska State Teachers basketball game at 8 p. m. in Allee Gymnasium.

## Meeting of Board Of Trustees Held

The board of trustees of Morningside college met October 9 on the Morningside campus with Leon Hickman '22, president of the board, presiding. Mr. Hickman is executive vice president of the Aluminum Company of America, with his office in Pittsburgh, Pennsylvania.

A new presidential scholarship program for outstanding prospective Morningside students was approved by the board. Under this set-up, 10 new four-year scholarships, amounting to \$2,000 per student divided into four annual grants of \$500 each will be given to high school graduates who have shown outstanding academic, social and spiritual qualities during their high school program and who must have this kind of financial help in order to come to Morningside.

President J. Richard Palmer also reported that the division of college and university assistance of the federal governments has approved \$230,218.00 in National Defense Student Loan funds for the 1962-63 college year at Morningside.

To date, the defense loan committee has committed \$167,935.00 to 268 students. Of these, 181 are returning students and 87 are new students.

The total amount advanced to students since the inception of this program two years ago added to the \$167,935.00 now committed for 1962-63 totals \$541,640.00.

According to President Palmer, one of the brightest spots in the entire picture of campus life is the national rating of entering freshmen. "Compared with other freshmen across the nation, four years ago only 37% of our freshmen taking the Ohio State Psychological tests, scored in the upper half. This year 65% of our first year students registered in the upper half of the national scoring. This increase is the result of higher admission requirements and has resulted in a 30% rise in total enrollment while the number of entering freshmen has remained rather steady. The explanation is, of course, that as more students enroll who are capable of doing college level work, more students stay on through the four year program, and fewer students fall by the wayside," commented President Palmer.

Carrol Smith, chairman of the finance committee of the college, re-

ported to the trustees that next year's budget will be \$1,744,000 compared to a similar figure of \$1,624,000 expended last year.

Also included in President Palmer's fourth annual report on the Morningside college projected Twelve Year Blueprint was the fact that summer school enrollment has more than doubled since 1960 under the summer semester plan.

President Palmer indicated, "First, we moved to a ten-week period, dividing it into two five-week (one semester) phases. By lengthening the class period and increasing the class schedule, we can give the teacher and student as many class hours in five weeks as we normally have in an eighteen week period during the regular school year.

"Of necessity only two courses can be fitted into a given five-week period. However, a student can thus add twelve semester hours of work during the summer, which is three-fourths of a normal semester load.

"Other factors in this move which help us to make better use of classroom and teaching resources during an otherwise slack period, are the air-conditioning of the library and a rather intensive publicity campaign among Sioux City students who attend other universities and colleges during the regular academic year," reported Dr. Palmer.

A new and greatly improved faculty salary scale was adopted. The maximum salary available for full professors was moved from \$9,500 to \$12,000 for the nine month academic year.

## Eidsmoe Presents Report At Washington Meeting

Professor Russell M. Eidsmoe, head of the department of education, attended a meeting in Washington, D. C., of the American Association of Colleges for Teacher Education. Mr. Eidsmoe presented a report of a sub-committee studying teacher education in liberal arts colleges.

## Choral Masterworks Program

The choirs and orchestra of the college presented another program in their continuing series of Choral Masterworks at Grace Methodist church in November. The program consisted of the Requiem by Gabriel Faure, Two Motets by Anton Bruckner, and Two Psalms by the 20th

century English composer, Gustave Holst.

Three students shared solo responsibilities. They were: Mary Doll Reinders, soprano of Orange City; Patricia Ayers, soprano of Sheldon; and Gerald Walker, baritone of Iowa Falls. Professor Wade Raridon of the Music department was the tenor soloist.

Dr. James Wood directed the choirs and orchestra.

## Miss Elsie Muller

### Completes Leave of Absence

Miss Elsie Muller, Morningside College mathematics instructor who has been on leave of absence since 1958, will return to Morningside next fall.

For the past four years Miss Muller has been teaching and carrying on graduate work at the Iowa State University in Ames. She is a candidate for the Ph.D. degree from Iowa State this coming June.

Prior to coming to Morningside in 1955, Miss Muller received her bachelor's degree from Wayne, Nebraska, State Teachers College; and her master's degree from the University of Michigan. In addition, she has studied at the University of Nebraska, the University of Southern California, and at Purdue University as recipient of a General Electric Mathematics Fellowship.

## Dr. Theodore Bauer Returns to Campus

Dr. E. Theodore Bauer will return to Morningside College next fall as head of the department of sociology. Dr. Bauer is currently professor of sociology and family life at California Western University in San Diego, California, where he has been for the last year.

Dr. Bauer, a native of West Chester, Iowa, received his B. A. degree from Iowa Wesleyan College, his M. A. from Drake University, and his Ph.D. from the State University of Iowa. An ordained Methodist minister, Dr. Bauer was professor of sociology at Iowa Wesleyan from 1947-49. He came to Morningside in 1949 and remained until 1955, when he became head of the department of sociology and religion at Iliff School of Theology for one year. He returned to Morningside in 1956, remaining until last year.

Dr. Bauer is widely known as an authority on marriage and family problems. He served on the Board



of Directors of Family Service, Inc., in Sioux City, and is a member of the Sioux City Social Workers Club. He is also a member of the American Association of Marriage Counselors. Dr. Bauer is past president of the Sioux City chapter of the American Interprofessional Institute and is presently a member of the National Board of Directors.

## School Superintendents On Campus

Approximately two hundred Superintendents of School attended the annual Superintendent's Conference on October 10, sponsored by Morningside.

The conference, under the direction of Professor Russell M. Eidsmoe, head of the department of education, featured as key-note speakers Leslie S. Brady, assistant director of the U. S. Information Agency, and formerly counselor of the U. S. Embassy for Cultural Affairs in Moscow, and Dr. J. W. Maucker, president of State college of Iowa.

Dr. Maucker addressed the conference at the morning session in The Commons. His topic was "Working for Excellence."

Mr. Brady addressed the group at the noon luncheon at the Sheraton-Martin hotel. His topic was "Impressions of Two Years in Russia".
