Honored For Research



Dr. Silas A. Braley, Morningside graduate of the class of 1913, was chosen a man-of-the-year by the Pittsburgh Junior Chamber of Commerce. Dr. Braley, a senior fellow at Mellon Institute, was selected to represent the profession of scientific research. He was honored for his work in mine acid control.

A stream pollution problem exists in most coal mining areas. Dr. Braley's work, the first concerted effort in the mine acid control field, resulted in a 300 page report which summarized years of research. This information has laid a foundation for development of improved control methods.

Dr. Braley received his Masters and Ph. D. from the University of Illinois and was a member of the faculty of that university. In 1927 he went to Mellon Institute and in 1946 became head of the Mine Acid Control Fellowship.

Si and Sara Braley (Sara Whitehouse '13) live at No. 7 Highland Court, Pittsburgh. They have three sons and a daughter. One son is doing chemical research for Dow Chemical Company, one is in business in Los Angeles, and one studying nuclear physics. Their daughter teaches nursing chemistry at the University of Pittsburgh.

DR. STOUFFER WRITES ARTICLE

Dr. Samuel Stouffer '21, professor of sociology at Harvard University, is the author of an article published in Look magazine this month concerning the results of a survey sponsored by the committee of the Fund for the Republic.

The study showed that the majority of Americans worry solely about personal and family problems, and that few are concerned about possible war. It also showed that few Americans know what a communist is and less than 1% volunteered any concern about an internal communist threat.

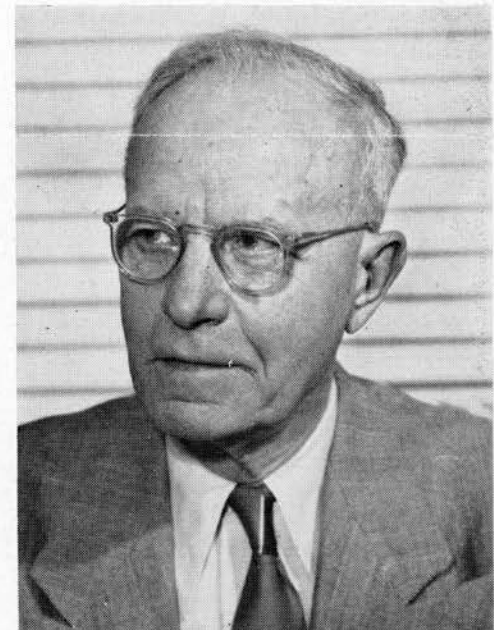
May 28--Alumni Day

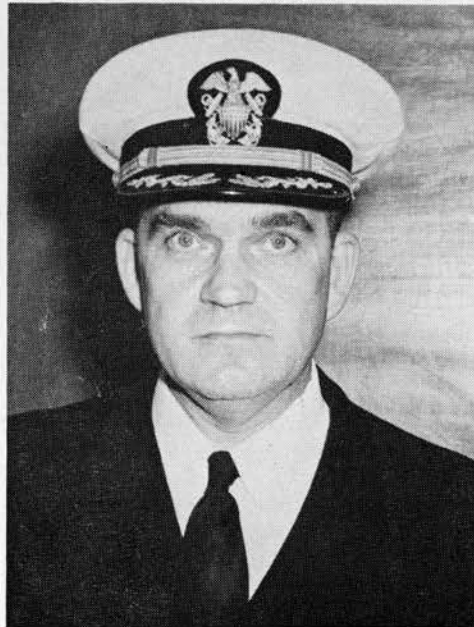

Charles City Graduate

DR. DANIEL STARCH

Dr. Daniel Starch '03 (Charles City College), president of Daniel Starch Staff Business Research, addressed the Invitational Conference on Testing Problems on the subject "And Have Not Wisdom". The conference met in New York in October.

Dr. Starch dealt with the problems which have arisen out of "the wide gap that exists today between the tremendous advance in science, particularly applied science, and the appalling backwardness still manifest in human relations."

Dr. Starch doubts that though due to our scientific knowledge we live longer and more comfortably, we live more wisely and happily.

To remedy the gap between "the advance of science and our discouraging delinquency in human relations" he suggests a three point plan of action.

"1. Recognize that knowledge of itself does not automatically lead to wise constructive use and that therefore we must set about specifically to seek and promote wise use.

"2. Determine what is wise use by evaluating proposed ideas and courses of action against the test of cause and effect, the test of spiritual survival value, the test of personal substitution between leader and led.

"3. Make the training of young people in making value judgments a consciously recognized part of our school and college teaching."

An old Grid-graph of a football game played on October 15, 1926 between Morningside and Des Moines University was found recently in the dismantling of the buildings that once housed that university.

The grid-graph was a complicated score board used before radio and television to inform the fans of a game away from home. It gave the viewer the down, the gain, type of play, period and score.

Gehrigs Honored

Mr. and Mrs. E. W. Gehring, 1912 graduates of the Charles City College which was merged with Morningside in 1914, were honored recently for their services to the Methodist Church and to the community of Howard, South Dakota.
