In the new library study material will be in four divisions, fine arts and natural sciences will be located on the ground floor, social sciences on the main floor, the humanities section on the mezzanine. There will be two sound proof listening rooms with high fidelity and recording equipment, two conference rooms, a seminar room, a library staff room, an audio visual laboratory, projection room, kitchenette, recreational reading alcove, faculty study room, and a chamber to house the records of the Northwest Iowa Conference of the Methodist Church.

FORD FOUNDATION GRANT

Morningside College was included in the college grants recently announced by the Ford Foundation. The gift is in the amount of \$154,800, and is designated for endowment with the yearly interest to be used for faculty salaries.

GRANT FROM ESSO

Morningside College was one of four Iowa colleges to receive a grant from the Esso Foundation, recently organized by Standard Oil of New Jersey and affiliated companies.

Morningside received \$2,000 in the form of an unrestricted grant for undergraduate education.

The Iowa schools were among 193 privately supported institutions among which \$566,000 was divided.

\$35,000 BEQUEST RECEIVED

Morningside College is the recipient of a \$35,00 bequest from the estate of Mrs. Hazel Straub Harstad of Evanston, Illinois. Mrs. Harstad was the widow of Oscar N. Harstad, a former vice president of the Milwaukee Road. She attended Morningside in 1904 and 1905. Mrs. Harstad died on October 18.

The will specified that the bequest be called the O. N. Harstad fund, and that no more than \$5,000 of the money could be spent in any one year.

RADIO HONOR FOR DON STONE

Don Stone ('51), Sioux City radio and television announcer, was selected in a nationwide search to substitute for Don McNeill as the master-of-ceremonies on the Breakfast Club. He will take over the network program on January 11 when McNeill takes a short vacation.

Roadmans' Trip

Dr. and Mrs. Roadman have begun making plans for a second European tour which they will conduct beginning July 5.

The President and his wife guided 14 persons on a sight-seeing and pleasure trip through England and the continent in the summer of 1954. Approximately 20 travelers may be included in the party this summer, Dr. Roadman said.

The tour will last two months and will cover France, Italy, Switzerland, Germany, Scandinavia and England. The group will dock at New York September 4, on the return trip. The transatlantic voyages will be made on the Cunard liner, Queen Mary.

The Roadmans are working in cooperation with the Schilling Tours service of Minneapolis.



The Rev. Charles A. Richards '08 died at Friendship Haven Fort Dodge on November 14. The funeral service was held at the Methodist Church in Humboldt on November 18. The Rev. Richards was a retired minister whose active service had been in the Northwest Iowa Conference.

The Morningside basketball team opened their season on November 26 by winning from Westmar 101-96 in an overtime game. On December 3 another overtime period chalked up a 79-72 victory over St. Cloud Teachers College. The game with Creighton, December 5, brought the Maroons their first defeat with a 59-54 score.

In their trip to the south where they played 4 games, the Morningside cagers won from Florida Southern, but lost to Eastern Illinois, Georgia State Teachers and the University of Florida.

The first conference games were played in North Dakota and ended with the Maroons on the small end of the score with North Dakota University, 69-61, and North Dakota State, 73-68.


