

New Courses, Faculty Members Mark Opening of Fall Semester...

Morningside's 1973-74 academic year opened with several new courses in the curriculum and several new faces among the faculty. The effect was to broaden the educational opportunities available to Morningside students and expose them to different areas of learning.

New programs are now available in nursing, in social work, special education, computer science, and language and writing. And in response to growing enrollments, another member has been added to the Art Department faculty.

Twenty-six freshman pre-nursing students are enrolled in the new program leading to a Bachelor of Science degree in Nursing (BSN). The students will begin nursing courses at the sophomore level.

Margaret Sokolowski, chairman of the Nursing Department, reports the program has been granted interim accreditation by the Iowa Board of Nursing and that graduates of the program will be eligible to write state licensing exams to become Registered Nurses.

The number of students enrolled in the nursing program was greater than had been anticipated. They represent New York, Iowa, Colorado, Nebraska and Missouri.

In order that students may establish a major in Social Work, the Sociology Department completed an

extensive revision of its social work program. The change reflects a demand from social agencies for more extensive preparation in social work for today's graduates.

The Education Department has introduced a minor in Special Education for the Mentally Retarded and has received accreditation for the program for the 1973-74 academic year. It is designed to accompany a major in Elementary Education in order that Morningside graduates can teach regular or special youngsters, or both.

And students interested in entering the "communication industry," or who feel that communication skills are essential to other careers, can now choose either a major or minor in English with an emphasis on writing and language.

The program provides intensive training in composition and in writing workshops, studies in language and bibliography, with electives in literature.

With the opening of the fall term, students were allowed for the first time to select a minor in computer science. Morningside, since installation of the 1130 computer several years ago, has offered courses related to computer science, including programming and seminar courses.

Now those who select the new minor will be able to choose from

such courses as Introduction to Computer Science, Introduction to Discrete Structures, Numerical Methods, Programming Languages, Data Structures and Advanced Topics of Computer Science.

New members of the faculty include:

DR. RICHARD OWENS, who will direct the new Special Education program as an associate professor of education. Dr. Owens was coordinator-director of Special Education for Merged Area XIV, an eight-county program headquartered at Creston, Iowa.

His background in education includes experience as a rural school teacher, an elementary principal, teaching at the junior high, high school and college levels, guidance counselor, school psychologist and director of education in a home for retarded children.

Dr. Owens has Bachelor of Science and Master of Science degrees from Chadron State College and received a Doctor of Education degree in Special Education from the University of Nebraska-Lincoln.

College Begins Construction of New Lincoln Center...

Walls of brick and concrete are beginning to tower over the nine-foot mountain of dirt that lies alongside Peters Avenue north of the Commons. What was recently a parking lot for students and staff has been transformed into a maze of excavations and projections bound together by mortar. The Robert M. Lincoln Center is well on its way to becoming the latest addition to the Morningside campus.

As The Morningsider reported in July, the initial funds for the building were provided through a \$200,000 gift from Robert Lincoln, a 1950 graduate, member of the college's board of directors and president of Payless Cashways Inc. The Kresge Foundation pledged a \$100,000 challenge grant and other

large gifts were presented by Perkins Bros. Co., Younkers, Payless Cashways and the Sooland Chapter of Chartered Life Underwriters.

Then in August President Thompson announced that he had completed funding of the building with major contributions from the Sioux City Bankers Association, Carter W. Dennis of Dennis Supply Co., Sioux City, the Board of Education of the United Methodist Church and a \$70,000 gift from The 1907 Foundation.

A large crowd of Morningside students, faculty and staff and people from the community assembled on the site Aug. 30 for a ground-breaking program. Serving as master of ceremonies, President Thompson introduced the

donors and civic leaders, and everyone took a turn with a shovel.

That evening the donors were honored at a dinner in the Randolph Room of the Commons.

Actually, it was a ground-breaking in name only. The large, bright orange trailer which serves as an on-site office for the Chris Hansen Construction Co. pulled onto the lot several days before and the earth movers and trenchers had rearranged the landscape considerably by ground-breaking day.

By Oct. 10 several large slabs of concrete had been poured for the ground-floor base. A 16-foot section of wall reached 10 foot in height and workers were setting block in the deep excavation in the rear to form a basement section.

When the \$476,000 facility is completed next summer, it will provide classroom, meeting room and office space for the Business Administration and Economics Departments, and for continuing education. More than 11,000 square feet of floor space will be added to the campus resources.

It will provide three classrooms designed to seat 30 students each, a seminar room, a departmental library, an assembly room designed for 154, a machine room housing key punch and calculator equipment for laboratory work in accounting, statistics and computer, a student-faculty lounge, and departmental and individual offices, including space for a Bureau of Business Research and an office for "visiting executives-in-residence."

Several of the rooms have been named. Plaques will designate the Dennis Seminar Room, the George D. Perkins Library and the 1907 Foundation Auditorium.

On evenings and weekends, much of the building's facilities will be utilized by many people from the community who are not regular students—those participating in the college's expanding continuing education program, including business and professional people. Examples are the current management development courses for business and industry and recent seminars on local government affairs, youth problems, retirement and the aging.

President Thompson hopes that business and industry can be encouraged to make full use of the building, not only to avail themselves of the classroom space whenever there is no conflict with college classes, but also to hold board meetings there. "Such an atmosphere would be of immense value to business administration students and perhaps could prove beneficial to the business community as well," he observed.

Under his direction, the college has been seeking to strengthen its ties with the surrounding community, including business and industry. The Lincoln Center, and the efforts of the college and the donors, are evidence that a firm bond is being formed.

Potpourri A Summary of Campus Events

46 RECEIVE DEGREES IN AUGUST CEREMONY

Forty-six students were awarded degrees from Morningside at summer commencement exercises August 17.

Those who were recognized at the 4 p.m. ceremony in Eppley Auditorium included 21 candidates for the Bachelor of Arts degree, 15 for Bachelor of Science and 10 for Master of Arts in Teaching.

The college also presented the honorary degree, Doctor of Humane Letters, to two members of the clergy, Rabbi Albert Gordon of Sioux City's Mount Sinai Temple and the Rev. John Payne, executive director of Goodwill Industries of San Joaquin Valley, Stockton, Calif.

Since his arrival in Sioux City in 1946, Rabbi Gordon has headed the local Ministerial Association, N.A.-A.C.P., Council of Community Services, Traveler's Aid and the Human Rights Commission.

A recognized scholar of Jewish history, he has taught courses in Morningside's Department of Religion on a part-time basis since 1956.

The Rev. Payne received a Bachelor of Arts degree from Morningside in 1943 while serving one of the city's Methodist churches. He was first associated with Goodwill in Philadelphia in 1949, later was executive director in Baltimore and Denver, and was named director of field services for the West Coast in 1968.

Morningside presented him with a Distinguished Alumni Award in 1963.

As commencement speaker, Rabbi Gordon warned that Americans must not allow such things as war and Watergate to make them cynical lest they miss the opportunity to fulfill their destiny.

"A cynical attitude toward ourselves and others will ultimately lead to disaster," he cautioned. "Society will become a veritable jungle in which it will be impossible to survive."

JIM WALKER DIRECTS DEVELOPMENT EFFORT

James A. Walker, a member of Morningside's admissions staff since 1970, began new duties June 1 as director of development at the college.

Walker succeeds Dr. C. Fred Phelps, who has returned to the faculty as chairman of the Speech and Drama Department after serving as acting dean of students for one year and development director since May 1971.

In his new position Walker will work with foundations, corporations, businesses and individual friends of the college to assure continued financial support for Morningside.

In addition to serving as assistant director of admissions, Walker has been staff coordinator for the long-range planning committee during the past year.

He is a native of Marshalltown, Iowa, attended Northwood-Kensett (Iowa) High School and was graduated from Bettendorf (Iowa) High School in 1966. At Morningside he majored in business administration and psychology.

As a student Walker served two terms as student body president and was appointed to the Student Development Council. He also was president of the Colleges of Mid-America student organization and was named a member of the Iowa Youth Commission in 1969.

DR. BASKERVILLE'S DEATH UNEXPECTED

Dr. M. Trevor Baskerville, administrative assistant to Bishop James S. Thomas of the United Methodist Church in Iowa, died unexpectedly in Des Moines Aug. 29. Death was believed to be due to a heart attack.

Dr. Baskerville, 57, had served as a member of the college's board of directors since 1968 and was awarded an honorary degree by Morningside in 1969.

In 1968 he was superintendent of the Sioux City district of the United Methodist Church and superintendent of the Mason City district from 1969 until last June, when he was appointed assistant to Bishop Thomas.

Survivors include Mrs. Baskerville, a son, Allyn of Lubbock, Tex., and a daughter, Mrs. Mary Lou Vasquez of Amarillo, Tex.

President and Mrs. Thompson represented the college at a memorial service.

NAME MRS. FRIESNER COLLEGE REGISTRAR

Mrs. Irene Holman Friesner, assistant registrar at Morningside since 1966, became registrar of the college on July 1. She succeeded Walter vonKlein, who is now registrar at Tulane University.

A native of Rockwell, Iowa, Mrs. Friesner was educated in the Mason City schools, received a Bachelor of Arts degree from the University of Iowa in 1931 and a Master of Arts in personnel and training from New York University in 1940.

Prior to joining the Morningside staff, she was personnel and training director of T.S. Martin Company, Sioux City; supervisor in the State Department of Education; personnel and training director of James Black Dry Goods and credit and accounts manager of Schmoller Piano Company. Both of the latter firms were based in Sioux City.

BAND TOURS EUROPE ON CONCERT SWING

Although transportation delays twisted schedules at times, members of the Morningside Band learned much about foreign countries and enjoyed themselves during a tour of Europe in July.

More than 30 musicians, their directors and chaperones made the trip through Greece, Italy, Austria, France and England. Concerts were presented along the route.

During the visit to Paris, some of the party met members of Dr. John Doohen's "Tour France Class," which spent the month of July in the Paris area studying the French language and culture.

FULL-TIME STUDENTS AT 1,167 FOR FALL

A total of 1,167 full-time undergraduate students are enrolled for the fall term, the Registrar's Office reports.

In addition, 64 part-time undergraduates, 43 graduate students and 198 evening school registrants raise the student population to 1,472.

The number of full-time students—those carrying 12 or more semester hours of college work—represents a 7 per cent decline from last year's

total of 1,257. At the same time, the number of part-time undergraduates was down four students from the 68 enrolled in September 1972.

The college experienced gains in the number of those taking graduate courses (from 22 to 43) and in evening school enrollment (180 to 193).

The registrar's report shows 404 freshmen, 283 sophomores, 243 juniors and 234 seniors among the full-time undergraduates.

FRED ERBES NAMED TO ADMISSIONS POST

President Thompson has announced the promotion of Fred Erbes to associate director of admissions.

Erbes, 34, joined the admissions staff in 1967 as a representative and has served as an assistant director since 1969. A native of Janesville, Wis., he was graduated from Sioux City's East High in 1957 and received a bachelor's degree in business administration from Morningside in 1962.

Erbes is a member of the National and Iowa Associations of College Admissions Counselors and presently is serving as college relations coordinator for the Northwest Iowa Personnel and Guidance Association.

Sports Outlook '73-'74

YOUNG CHIEFS IMPROVE BUT VICTORY ELUSIVE

The struggling Morningside Chiefs entered the second half of the grid season with an 0-4 record. Head Coach Dewey Halford summed up the first half with the observation:

"Our young kids are coming along, but we still have a long way to go. Again, as in the past, our lack of depth hurts us when injuries occur. Right now our running back corps is functioning with two healthy backs."

The North Central Conference is again very powerful, and after encountering North Dakota State and North Dakota U. on successive weekends the Chiefs, in the South Dakota U. game, were pitted against a nationally ranked power for the third consecutive weekend.

The season opener — against Southwest Minnesota State Sept. 15 at Marshall—was a heartbreaker as Morningside failed on a two-point conversion play in the fourth quarter and came out on the short end of a 7-6 score.

In the annual Shrine Game in Roberts Stadium the following Saturday, a powerful ground attack launched by the University of Nebraska-Omaha up-ended the Chiefs 31-6.

The squad bounced back with vigor against North Dakota State Sept. 29 in the second home game. While the home fans cheered, the Chiefs waged a hard-fought, nose-to-nose battle against the eleventh ranked Bison. With the elimination of a few mistakes, the team could have recorded Victory No. 1, but the final score was 14-0.

The Chiefs' improved play continued through the first period at Grand Forks the following Saturday, when the quarter ended with a 7-7 tie. But thereafter they were overpowered by the talented, na-

tionally ranked Sioux and suffered a 43-7 defeat.

After meeting the Coyotes of South Dakota U. on Oct. 13, the Chiefs were scheduled to meet the University of Northern Iowa in a homecoming battle at Roberts Stadium Oct. 20, then travel to Mankato State and Augustana on Oct. 27 and Nov. 3, and close out the season at home Nov. 10 against South Dakota State.

Defensively the Chiefs have shown steady improvement. Youth and inexperience have contributed to defensive breakdowns, but (with the exception of the disastrous third quarter at North Dakota U.) Morningside has shown excellent defense in recent contests.

Coach Halford hopes his young squad will continue to improve and maintain the excellent attitude the Chiefs have demonstrated so far this season.

SOPHOMORES HOLD KEY TO WRESTLING SEASON

Youthful optimism keynotes the upcoming mat season on the Morningside campus. Sophomores hold the key to continued success.

No less than six starting spots could be won by second year men. Jim Yount, 126, Rod Isaacson, 158, Kurt Mattison, 167, Kelly Greene, 177, Dave Kobliska, 190, and Jim Boyd, heavyweight, are the sophomore stalwarts. All are lettermen with the exception of Yount.

Seniors Steve Readout and Bill Boust may have a lot to say about the 177-and 190-weight classes.

A third senior, Mike Pickford, 134, will be facing the challenge of frosh State Champion Jim Sarver. Mike needs to rebound from a disappointing season last year in an attempt to regain the National Tournament form of his sophomore year.

Junior letterman Dave Edmonds and Junior College transfer Dave Galler will battle second year man Wayne Thomas and frosh Rod Fontch for the 142- and 150-pound classes. An outstanding freshman, Mark Montange, is expected to start the meets for the Chiefs at 118.

Last year's "Big Three," Rick Nuss, Frank Thompson and Steve Newhard, are gone—along with Dave Roder and Randy Thomas, who did not return for his junior year. The 103 matches won by these wrestlers presents a formidable replacement task. This year's squad thinks it can get the job done.

ELLIS NAMED 'SID' AT NORTHERN IOWA

George Ellis, sports information director at Morningside and sports editor of the Morningsider until this summer, has taken over as director of the sports information service at the University of Northern Iowa.

George, 28, is a 1971 graduate of Morningside. In addition to overseeing the Chiefs' publicity program, he was sports information chief for the North Central Conference in 1972-73.

His 1971-72 football programs and 1972 football press book were named "All American" by the National Association of Intercollegiate Athletics.

CHUCK OBYE JOINS STAFF OF Y.M.C.A.

Chuck Obye, Morningside's head basketball coach for 16 seasons, has accepted an appointment as associate director of the Sioux City Y.M.C.A.

He is in charge of the day-to-day administrative operation of the "Y" building, coordinates the various programs and is administrative assistant to the director.

Chuck, who resigned at the end of the spring semester, developed 13 all-North Central Conference athletes during his career at Morningside, which was the longest in the college's athletic history.

He was NCAA Coach of the Year in 1970 after he guided the Chiefs to the finals of the North Central Conference Holiday Basketball Tournament and narrowly missed a trip to the NAIA national tournament.

CHIEFS' CAGE SQUAD BOASTS NEW LOOK

The Maroon Chiefs basketball team will have a new look, new players and a new dedicated attitude which head coach Dan Callahan hopes will bring about a new way of life.

The "David" against the "Big Goliaths" of the North Central will accept the challenge of winning in the highly regarded conference and Callahan promises that a genuine effort is the very least that fans can expect. The players are backing their commitment with a determination that promises vigor, enthusiasm and excitement during the season.

The Chiefs' new look features a blend of veterans and in-coming sophomores and freshmen.

Heading the list of veterans are Scott Burgason (6'6"), Freeman Berry (6'3") and Dan Pomerence (5'10"). Callahan is counting on a good deal of help from newcomer Dave Schlessler (6'11") and promising sophomores Bobby Curry (5'11") and Marv Munden (6'1"), plus rookies Doug Marx (6'5"), Bill Lindgren (6'1") and Fred Evans (6'8").

Coach Callahan, making his debut at the helm of the Chiefs after a highly successful campaign in Iowa high school ball, believes this

year's team will have to show improvement in defense, shooting percentage and foul-shooting, the areas in which the club was weakest last year.

"I especially look forward to the defensive challenge," says Callahan. "Of course we will be starting with the fundamental defensive drills and developing pride. Improving defensive skills with these executions will be one of our foremost tasks. Along with this comes confidence. Then we are ready to build a team.

"Defense is going to be a real point of emphasis. The players are already sold on the offensive aspect of the game, and what we have to do is incorporate what each player does well offensively into the offense system.

"The main point offensively is, once we're organized, to take a better percentage shot and gain confidence in the system. Most of all, we'll be working on hitting the open man."

The players have convinced Callahan they are willing to work hard, to make a sincere effort and strive for success. "With that kind of serious attitude, I'm confident they will reach their goals," he said.

"Come to the games and enjoy yourselves," he urged Morningside fans. "I'm confident it's going to be a new and exciting season."

JOHN E. MACKEY, widely known sociologist and specialist on problems of the American Indian, will concentrate on the expanded Social Work program. He brings to the program a wealth of experience and expertise acquired through teaching, research, analysis and by solving social work problems.

A 1958 Morningside graduate who later obtained a Master of Social Work degree from the University of Iowa, Mackey has served as case-worker and director of state welfare programs at the local level and from 1965-67 was state director of the Office of Economic Opportunity. He later was appointed state director of the Iowa Comprehensive Alcoholism Project (ICAP).

Since 1971 Mackey has served as director of the Social Work Division at the University of South Dakota. Mackey will continue his research and evaluation work into Indian problems for the Department of Health, Education and Welfare.

BETTY J. BULLOCK will serve as an instructor in the Sociology Department. Miss Bullock was awarded a Bachelor of Arts degree from Baker University in 1970 and received a Master of Arts degree in Sociology from the University of Kansas last spring.

Upon completion of work for her master's degree, she began study at K.U. for a Ph.D. degree. For the past three years she served as a research assistant at the university.

DR. ROBERT P. JOHNSON, 32, will serve as director of the Jacobsen Computer Center and assistant professor in the Mathematics Department.

He comes to Morningside from Ohio State University, where he had served as assistant professor of mathematics since 1967.

A native of Norfolk, Va., Dr. Johnson received a Bachelor of Arts degree in 1962 from the University of San Diego, where he graduated magna cum laude, and a Ph.D. in mathematics from the University of Notre Dame in 1967.

He succeeds James McDonald, a 1958 Morningside graduate, who assumed new duties this fall as director of computer services and lecturer in computing at Grinnell College.

DR. JACQUELYN M. MILLER, with a broad background in elementary education, has joined the Morningside Education Department. At the time of her appointment she was assistant professor of education on the Evansville campus of Indiana State University.

Dr. Miller, a native of Omaha, received a Bachelor of Science degree from Arizona State College in 1963. In 1972 she was awarded a Doctor of Education degree from the University of Nebraska-Lincoln.

Dr. Miller has taught in the elementary grades of the Omaha public schools and served as a classroom teacher for the U.S. Department of Defense at Bremerhaven, Germany. She was appointed to the Indiana State faculty in 1972.
